


EXPLANATORY NOTE

For years, the San Isidro National High School - Calabnigan Annex operates under the supervision and administration of the San Isidro National High School.

This Bill proposes to separate the San Isidro National High School - Calabnigan Annex from the San Isidro National High School and to convert the same into a national high school to be known as the Calabnigan National High School, in Barangay Calabnigan, in the Municipality of Libmanan, Camarines Sur.

As a separate and distinct learning institution, the Calabnigan National High School would enable its administration to be more responsive to the needs of its students as well as to improve the quality of education it offers.

Hence, immediate approval of this bill is earnestly sought.

AN ACT SEPARATING THE SAN ISIDRO NATIONAL HIGH SCHOOL-CALABNIGAN ANNEX IN BARANGAY CALABNIGAN, MUNICIPALITY OF LIBMANAN, PROVINCE OF CAMARINES SUR FROM THE SAN ISIDRO NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS CALABNIGAN NATIONAL HIGH SCHOOL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

Section 1. *Separation and Conversion into a National High School.* The San Isidro National High School - Calabnigan Annex in Barangay Calabnigan, Municipality of Libmanan, Province of Camarines Sur is hereby separated from the San Isidro National High School and converted into an independent national high school to be known as Calabnigan National High School.

Section 2. *Transfer of Assets and Liabilities.* All personnel, assets, liabilities and records of the San Isidro National High School - Calabnigan Annex are hereby transferred to and absorbed by the Calabnigan National High School.

Section 3. *Appropriations.* The Secretary of Education shall immediately include in the Department's program the operationalization of the Calabnigan National High School, the initial funding of which shall be charged against the current year's appropriations of the San Isidro National High School - Calabnigan Annex. Thereafter, the amount necessary for the continued operation of the school shall be included in the annual General Appropriations Act.

Section 4. *Implementation.* The Secretary of Education shall issue rules and regulations that may be necessary to carry out the purpose of this Act.

Section 5. *Effectivity.* This Act shall take effect fifteen (15) days after its publication in this *Official Gazette*.
